Step #1: Immediate Needs Evaluation by Nimkee Nupigawagan Healing Centre

Note: The intent of this step is for Nimkee Nupigawagan Healing Centre to assess that the youth's immediate needs can be met in the residence. The information in (a) to (i) must be provided to Nimkee Nupigawagan Healing Centre by the youth's placing agency or the person placing the youth in circumstances where the placing agency is <u>not</u> the Nimkee Nupigawagan Healing Centre.

Note: <u>Section 2 of O. Reg. 156/18</u> provides that a reference to a youth's identity characteristics means: "a reference to the youth's race, ancestry, place of origin, colour, ethnic origin, citizenship, family diversity, disability, creed, sex, sexual orientation, gender identity, gender expression or cultural or linguistic needs.

ACTION REQUIRED BY THE PLACING AGENCY:

Step #1: Provide the Nimkee Nupigawagan Healing Centre with the following information (except where the placing agency is the Nimkee Nupigawagan Healing Centre):

- 1. The youth's name, age and gender.
- 2. The objectives of the person placing the youth or the placing agency.
- 3. Information about the immediate needs of the youth that is reasonably necessary for the purposes of performing the pre-admission assessment
- 4. The basis on which the youth is in the society's care where the youth is being placed by a society
- 5. Any behaviours of the youth that may pose a safety risk and any safety measures that should be implemented to mitigate those risks if the youth were admitted
- 6. The circumstances necessitating out of home care.

7. Any other information that is relevant to the provision of out of home care by the Nimkee Nupigawagan Healing Centre.

Step #2: Consultation & Assessment of Whether the Youth's Immediate Needs Would be Met:

CONDITIONS ON PLACEMENT:

A Nimkee Nupigawagan Healing Centre cannot accept a youth to be admitted unless they have:

I. Completed all the required steps as part of the pre-placement/pre-admission assessment process described in <u>O. Reg. 156/18, s. 86.2</u> (youth residences & staff model homes), and

II. If the youth engages in behaviours that may pose a risk to the safety of the youth or others or if there are risks to the youth's safety known to the Nimkee Nupigawagan Healing Centre, conducted a safety assessment as required by regulation and, if required, prepared a safety plan.
